## Patient Satisfaction Survey Season Continues

Through June, VNSNY CHOICE Total enrollees may receive a survey from **Consumer Assessment of Healthcare Providers and Systems (CAHPS)** on behalf of Centers for Medicare and Medicaid Services (CMS) concerning their Medicare and Part D plans. Both surveys ask for feedback on, among other things, the quality and accessibility of the services they receive from care providers and health plans.

## Pharmacy “Carve-Out” Delayed Two Years

New York State has postponed the transition of the pharmacy benefit from Medicaid Managed Care plans to Medicaid Fee-for-Service by two years to **April 2023**.

The carve-out would have harmed SelectHealth’s ability to manage care for the at-risk population we serve, including those living with HIV/AIDS. The postponement follows more than a year of advocacy by SelectHealth and the other HIV SNPs, as well as our plan associations, a coalition of Community Health Centers and other safety net providers and stakeholders committed to protecting the health and interests of this vulnerable population.

We have a reprieve, but we will continue advocating to maintain the current benefit as part of the HIV SNP plan to support members’ overall needs and help them be as healthy as possible.

### SelectHealth Update: A Good Time to Test for STIs

Now is a great time to make sure your patients are tested for **Sexually Transmitted Infections (STIs)**. In particular, we are urging testing for the following SelectHealth patients:

- All patients living with HIV should be tested annually for chlamydia, gonorrhea and syphilis.
- All sexually active individuals assigned female at birth who are younger than 25 years, as well as those with risk factors such as new or multiple sex partners, or a sex partner who has a sexually transmitted infection, should have an annual chlamydia and gonorrhea screening.
- All sexually active men who have sex with men should receive a screening for syphilis, chlamydia and gonorrhea (at the appropriate anatomic sites of exposure based on sexual practices) at least once a year.
- Pregnant persons should get syphilis, HIV, chlamydia and hepatitis B screenings. At-risk pregnant individuals should get a gonorrhea screening starting early in their pregnancy with repeat testing as needed.

- Anyone who has unprotected sex or shares injection drug equipment should get tested for HIV at least once a year and referred to mental health or substance use support services as needed.
- People living with HIV who have unprotected sex or share injection drug equipment should have their viral load closely monitored and be referred to mental health or substance use support services as needed.

## **PrEP to Prevent HIV and Promote Sexual Health**

If your patient is HIV negative, Pre-Exposure Prophylaxis (PrEP) is a safe, daily pill that protects them from HIV. It's a powerful tool in helping to End the AIDS Epidemic as well as to help them take control of their sexual health.

Studies have shown that PrEP is safe and reduces the risk of getting HIV from sex by about 99% when taken daily (CDC). The New York State Department of Health AIDS Institute has released guidance and other resources for PrEP which [you can find here](#).
